RIGHT OF WITHDRAWAL

Pursuant to Royal Legislative Decree 1/2007 of 16 November, approving the consolidated text of the General Law for the Defence of Consumers and Users and other complementary laws, consumers have the right to withdraw from a distance contract (by telephone, internet, postal mail, fax, at home, etc.) within a period of fourteen (14) calendar days without giving any reason.

The withdrawal period shall expire after fourteen (14) calendar days from the day of conclusion of the contract, or, where applicable, from the day on which the consumer or a third party indicated by the consumer, other than the carrier, acquired physical possession of the goods, or of the last of the goods or the last item forming part of the same order.

To exercise the right of withdrawal, the consumer must notify their decision to withdraw from the contract by means of an unequivocal statement (for example, a letter sent by post, fax or email). The consumer may use this model withdrawal form, although its use is not mandatory.

The consumer may also complete and submit this withdrawal form electronically or submit any other unequivocal statement, attaching the document and sending it to info@tequilasu.com

In such cases, the consumer will receive an acknowledgement of receipt of the withdrawal on a durable medium (for example, by email) without undue delay.

To meet the withdrawal deadline, it is sufficient for the communication concerning the exercise of this right to be sent by the consumer before the withdrawal period has expired.

The exercise of the right of withdrawal shall terminate the obligations of the parties to perform the contract or to conclude it when the consumer has made an offer. In such cases, provided that the above conditions are met, all payments received shall be reimbursed, including delivery costs where applicable, without undue delay and in any event no later than fourteen (14) calendar days from the date on which the trader is informed of the consumer's decision to withdraw from the contract.

The reimbursement shall be made using the same means of payment as that used for the initial transaction, unless the consumer has expressly agreed otherwise, and provided that the consumer does not incur any fees as a result of the reimbursement.

The right of withdrawal shall not apply to contracts listed in Article 103 of Royal Legislative Decree 1/2007 of 16 November.
